**Last Date of Admission: 11th August, 2025**

**COMMENCEMENT DATE OF THE ACADEMIC SESSION – 25th AUGUST, 2025**

Students accepted into the MA English Programme at Ashoka University can opt for residential accommodation provided by the university, or choose to travel at their own convenience. However, those who opt to be day scholars and not opt for the accommodation provided by the university may face problems as some mandatory courses and guest sessions are held in the evenings.

Please note that the fee structure and refund policy below will vary depending on a student's choice to opt for accommodation or plan their own accommodation and travel to the university. Fee Structure and Refund policy for both of these options have been provided below.

**Acceptance Fee and Security Deposit**  
**(To be paid by 15th June, 2025)**

- A. If a student **does not opt for Residential accommodation provided by the University**, they will be required to deposit an amount of **INR 1,68,050** to confirm their offer of admission by the acceptance deadline.

*This amount includes the following:*

1. Tuition Fee of INR 1,48,050 (adjusted in semester 1 tuition fee)
2. Refundable Security Deposit of INR 20,000 (One-time payment to be refunded at the time of graduation from Ashoka University or withdrawal of admission)

- B. If a student **opts for Residential accommodation provided by the University**, they will be required to deposit an amount of **INR 1,93,050** to confirm their offer of admission by the acceptance deadline.

*This amount includes the following:*

1. Tuition Fee of INR 1,48,050 (adjusted in semester 1 Tuition Fee)
2. Refundable Security Deposit of INR 20,000 (One-time payment to be refunded at the time of graduation from Ashoka University or withdrawal of admission)
3. Refundable Meal Cost Security Deposit of INR 25,000 (One-time payment to be refunded at the time of graduation from Ashoka University or withdrawal of admission)

### **Semester 1 Fee**

**(To be paid by 20th July, 2025)**

- A. If a student **does not opt for Residential accommodation provided by the University**, they will only be required to deposit an amount of **INR 1,48,050**, which is the remaining amount due toward the Semester 1 Tuition Fee.
- B. If a student chooses to **opt for Residential accommodation provided by the University**, they will be required to deposit an amount of **INR 1,98,250**.

This amount includes the following:

- 1. Semester 1 Tuition Fee of INR ,148,050
- 2. Residence Cost of INR 50,200

### **Semester 2 Fee**

**(To be paid by mid-January, 2026)**

If a student **does not opt for Residential accommodation provided by the University**, they will be required to deposit an amount of **INR 2,96,100**, which is the Semester 2 Tuition Fee.

If a student chooses to **opt for Residential accommodation provided by the university**, they will be required to deposit an amount of **INR 3,46,300**.

This amount includes the following:

- 1. Semester 2 Tuition Fee of INR 2,96,100
- 2. Residence Cost of INR 50,200

### **Please Note:**

Meals – A minimum amount of **INR 10,000** toward meals and dining facilities will be charged at the end of each semester (the minimum amount for one year is INR 20,000)

## **Ashoka University Refund Policy and Amount**

### **Withdrawal of Admission details as per University Grants Commission Guidelines**

1. If a student withdraws their admission before or on **July 27, 2025** the student will receive a refund of the entire Security Deposit of INR 20,000 and Meal Cost Security Deposit of INR 25,000 (If opted in for Residence and Meals) and a 100% percent refund of the remaining fees paid, less a 5% deduction as administrative processing fee subject to a maximum of INR 5,000 (If withdrawal of admission is 15 days or more before the officially notified last date of admission)
2. If a student withdraws their admission from **July 28, 2025 to August 11, 2025** the student will receive a refund of the entire Security Deposit of INR 20,000 and Meal Cost Security Deposit of INR 25,000 (If opted in for Residence and Meals), and 90% of the remaining fees paid (If withdrawal of admission is less than 15 days before the officially notified last date of admission)
3. If a student withdraws their admission from **August 12, 2025 to August 25, 2025** the student will receive a refund of the entire Security Deposit of INR 20,000 and Meal Cost Security Deposit of INR 25,000 (If opted in for Residence and Meals) and 80% of the remaining fees paid (If withdrawal of admission is 15 days or less after the officially notified last date of admission)
4. If a student withdraws their admission from **August 26, 2025 to September 10, 2025** the student will receive a refund of the entire Security Deposit of INR 20,000 and Meal Cost Security Deposit of INR 25,000 (If opted in for Residence and Meals) and 50% of the remaining fees paid (If withdrawal of admission is 30 days or less, but more than 15 days, after the commencement date of the academic session)
5. If a student withdraws their admission on or after **September 11, 2025** none of the fees paid will be refunded. The student will only be refunded the Security Deposit of INR 20,000 and INR 25,000 (If opted in for Residence and Meals) (If withdrawal is more than 30 days after the commencement date of the academic session)

### ***Please note the following:***

- The above refund details are based on the amount(s) deposited by the student within the given payment deadlines of Ashoka University
- The refund amount will differ for students based on the amount of financial aid granted to them
- All refunds will be processed within 4 weeks from the date of the request for withdrawal of admission
- Ashoka University reserves the right to change, modify, add, or remove portions of the refund policy at any time by posting the amended policy after taking necessary approvals. Students are advised to check the policy periodically for changes and/or updates
