FEE STRUCTURE AND REFUND POLICY [August 2022 intake]

Important Dates

- Last Date of Admission – **10th August, 2022**
Academic Orientation (Online) – **16th August, 2022**
Registration and Moving into Campus – **20th and 21st August, 2022**
Welcome Session for Parents and Guardians – **21st August, 2022**
Commencement Date and Student Orientation – **22nd August, 2022**
Academic Classes (Semester 1) – **29th August, 2022 onward**

Acceptance Fee and Security Deposits

(To be paid by Round-Wise Acceptance Deadline)

The candidate will be required to deposit an amount of **INR 3,41,750** to confirm their offer of admission by the acceptance deadline of the round in which they have applied. This above-given Acceptance Fee amount includes the following:

- Admissions Fee of INR 50,000
- Tuition Fee of INR 2,16,750
- Refundable Security Deposit of INR 50,000 and Refundable Meal Cost Security Deposit of INR 25,000 (One-time payments to be refunded at the time of graduation from Ashoka University or withdrawal of admission)

Semester 1 Fee Deposit

(To be paid by the Round-Wise Semester-1 Fee Payment Deadline)

The candidate will be required to deposit the remaining Semester 1 Tuition Fee and Residence Cost of **INR 3,01,750** to ensure that they secure their seat in Ashoka University's Undergraduate Programme for the session commencing on August 23, 2021. This amount includes the following:

- Remaining Semester 1 Tuition Fee of INR 2,16,750
- Semester 1 Residence Cost of INR 85,000

Semester 2 Fee Deposit

(To be paid by mid-January 2023)

The candidate will be required to deposit an amount of **INR 5,18,500** toward their Semester 2 Fee. This amount includes the following:

- Semester 2 Tuition Fee of INR 4,33,500
- Semester 2 Residence Cost of 85,000

Note on Meals – A minimum amount of INR 17,500 (Fixed Cost – INR 4,000 & Variable Cost – INR 13,500) toward meals and dining facilities will be charged at the end of each semester (minimum amount for one year is INR 35,000)

Ashoka University Refund Policy - Undergraduate Programmes
[August 2022 intake]

The officially notified Last Date of Admission is 10th August, 2022. Below are the Refund Details on Withdrawal of Admission by the Candidate:

1. If a candidate withdraws their admission before or on July 27, 2022, the candidate will receive a refund of the entire Security Deposit of INR 75,000 and a 100% percent refund of the remaining fees paid, less a 5% deduction as administrative processing fee subject to a maximum of INR 5,000 (If withdrawal of admission is 15 days or more before the officially notified last date of admission)
2. If a candidate withdraws their admission from July 28, 2022 to August 10, 2022, the candidate will receive a refund of the entire Security Deposit of INR 75,000, and 90% of the remaining fees paid (If withdrawal of admission is less than 15 days before the officially notified last date of admission)
3. If a candidate withdraws their admission from August 11, 2022 to August 25, 2022, the candidate will receive a refund of the entire Security Deposit of INR 75,000, and 80% of the remaining fees paid (If withdrawal of admission is 15 days or less after the officially notified last date of admission)
4. If a candidate withdraws their admission from August 26 , 2022 to September 9, 2022, the candidate will receive a refund of the entire Security Deposit of INR 75,000 and 50% of the remaining fees paid (If withdrawal of admission is 30 days or less, but more than 15 days, after the officially notified last date of admission)
5. If a candidate withdraws their admission on or after September 10, 2022, none of the fees paid will be refunded. The candidate will only be refunded the Security Deposit of INR 75,000 (If withdrawal is more than 30 days after the officially notified last date of admission)

Please note the following:

- The above refund details are based on the amount(s) deposited by the candidate within the given payment deadlines of Ashoka University
- The refund amount will differ for candidates based on the amount of financial aid granted to them
- All refunds will happen within 4 weeks from the date of request for withdrawal of admission
- Ashoka University reserves the right to change, modify, add, or remove portions of the policy at any time by posting the amended policy after taking necessary approvals. Candidates are advised to check the policy periodically for changes
