Update on Reopening

The Vice Chancellor apprised the members of the Governing Body regarding the steps taken by the University during the coronavirus (COVID-19) pandemic for continuing teaching learning activities through online mode since March 2020. The Vice Chancellor informed that online teaching at University is very good and students are very happy. The Vice Chancellor made a special mention of the efforts of faculty, teaching fellow (TF), teaching assistants (TA) and IT team for the success of online teaching.

The Vice Chancellor further briefed regarding the University Remote Teaching and Learning Handbook that was developed by the faculty to support teaching and learning

in an online environment. University has received the QS I-Gauge E-LEAD (E-Learning Excellence for Academic Digitisation) Certification and Badge. Economics at Ashoka University has been ranked no 1 in India in terms of research output according to the internationally accepted RePEc rankings.



Discussion held between the members of Governing Body on the reopening of campus. Dr. Verma shared that guidelines regarding reopening of the college / University have been issued by the Department and the institutions have right to amend the guidelines as per their suitability. In Government institution in Haryana, the students are coming to the institutions w.e.f. November 16, 2020. As per the guidelines, students are allowed to come to the institutions with the consent signed by the parent. In the hostels sharing of the room is not allowed. Only one student per room is allowed and attendance is not compulsory. In Government Institutions if the students would like to come to hostel, they have to show the —ve COVID test.
