

ASHOKA UNIVERSITY FEE STRUCTURE AND REFUND POLICY [August 2023 intake]

Important Dates

Last Date of Admission – **4th August, 2023** Academic Orientation (Online) – **16th and 17th August, 2023** Registration and Moving into Campus – **19th** and **20th August, 2023** Welcome Session for Parents and Guardians – **20th August, 2023** Commencement Date and Student Orientation – **21st August, 2023** Academic Classes (Semester 1) – **28th August, 2023 onward**

Acceptance Fee and Security Deposits

(To be paid by Round-Wise Acceptance Deadline)

The candidate will be required to deposit an amount of **INR 3,56,750** to confirm their offer of admission by the acceptance deadline of the round in which they have applied. This above-mentioned Acceptance Fee amount includes the following:

- Admissions Fee of INR 50,000
- Partial Semester 1 Tuition Fee of INR 2,31,750
- Refundable Security Deposit of INR 50,000 and Refundable Meal Cost Security Deposit of INR 25,000 (One-time payments to be refunded at the time of graduation from Ashoka University or withdrawal of admission, whichever is earlier)

Semester 1 Fee

(To be paid by the Round-Wise Semester-1 Fee Payment Deadline)

The candidate will be required to deposit the remaining Semester 1 Tuition Fee and Residence Cost of **INR 3,22,250** to ensure that they secure their seat in Ashoka University's Undergraduate Programme for the session commencing on August 21, 2023. This amount includes the following:

- Remaining Semester 1 Tuition Fee of INR 2,31,750
- Semester 1 Residence Cost of INR 90,500

Semester 2 Fee

(To be paid by mid-January 2024)

The candidate will be required to deposit an amount of **INR 5,54,000** toward their Semester 2 Fee. This amount includes the following:

- Semester 2 Tuition Fee of INR 4,63,500
- Semester 2 Residence Cost of 90,500

Note on Meals – A minimum amount of INR 20,000 per semester will be charged toward meals and dining facilities at the end of each semester (minimum amount for one year is INR 40,000). Any changes made to the above-mentioned amount will be communicated with students at the earliest.



Ashoka University Refund Policy - Undergraduate Programmes [August 2023 intake]

The officially notified Last Date of Admission is <u>4th August</u>, <u>2023</u>. Below are the Refund Details on Withdrawal of Admission by the Candidate:

1. If a candidate withdraws their admission before or on **July 21**, **2023**, the candidate will receive a refund of the entire Security Deposit of INR 75,000 and a 100% percent refund of the remaining fees paid, less a 5% deduction as administrative processing fee subject to a maximum of INR 5,000 (If withdrawal of admission is 15 days or more before the officially notified last date of admission)

2. If a candidate withdraws their admission from **July 22**, **2023** to **August 4**, **2023**, the candidate will receive a refund of the entire Security Deposit of INR 75,000, and 90% of the remaining fees paid (If withdrawal of admission is less than 15 days before the officially notified last date of admission)

3. If a candidate withdraws their admission from **August 5**, **2023** to **August 18**, **2023**, the candidate will receive a refund of the entire Security Deposit of INR 75,000, and 80% of the remaining fees paid (If withdrawal of admission is 15 days or less after the officially notified last date of admission)

4. If a candidate withdraws their admission from **August 19**, **2023** to **September 3**, **2023**, the candidate will receive a refund of the entire Security Deposit of INR 75,000 and 50% of the remaining fees paid (If withdrawal of admission is 30 days or less, but more than 15 days, after the officially notified last date of admission)

5. If a candidate withdraws their admission on or after **September 4**, **2023**, none of the fees paid will be refunded. The candidate will only be refunded the Security Deposit of INR 75,000 (If withdrawal is more than 30 days after the officially notified last date of admission)

Please note the following:

- The above refund details are based on the amount(s) deposited by the candidate within the given payment deadlines of Ashoka University
- The refund amount will differ for candidates based on the amount of financial aid granted to them
- All refunds will happen within 4 weeks from the date of request for withdrawal of admission
- Ashoka University reserves the right to change, modify, add, or remove portions of the policy at any time by posting the amended policy after taking necessary approvals. Candidates are advised to check the policy periodically for changes
